Management Discussion and Analysis For the Period Ended July 31, 2023

The Management Discussion and Analysis ("MD&A") of Cassius Ventures Ltd. (the "Company") has been prepared by management in respect of the three and nine months ended July 31, 2023 and should be read in conjunction with the Company's unaudited condensed interim financial statements for the three and nine months ended July 31, 2023 and related notes thereto, as well as the Company's audited financial statements for the year ended October 31, 2022 and the related notes thereto. The Company reports its financial statements in accordance with International Financial Reporting Standards ("IFRS") as issued by the International Accounting Standards Board. All figures are reported in Canadian dollars unless otherwise indicated.

Certain information included in this discussion may constitute forward looking statements. Forward looking statements are based on current expectations and entail various risks and uncertainties. These risks and uncertainties could cause or contribute to actual results that are materially different from those expressed or implied. The effective date of this report is September 28, 2023.

Description of Business

The Company is an exploration stage company focused on acquiring exploration and/or development stage mineral properties for the purposes of further exploration and development. The Company was incorporated on February 23, 2007 by Certificate of Incorporation issued pursuant to the provisions of the Business Corporations Act of British Columbia under the name "Cassius Ventures Ltd.". The Company currently trades on the NEX Board of the TSX Venture exchange under the symbol "CZ.H".

The Company continues its pursuit of a viable property of merit in conjunction with a financing to support the exploration or development of such a property.

Liquidity & Capital Resources

The financial statements have been prepared on a going concern basis, which assumes that the Company will continue in operation for the foreseeable future and will be able to realize its assets and discharge its liabilities in the normal course of business.

The Company has yet to generate any revenues from operations and as at July 31, 2023, had an accumulated deficit of \$6,699,245 and a working capital deficit of \$410,189.

The Company's working capital balance currently limits the Company's ability to fund significant capital expenditures and operations. These conditions, along with other factors indicate the existence of material uncertainties that may cast significant doubt upon the Company's ability to continue as a going concern.

The continuation of the Company as a going concern is dependent on securing additional funding through equity or debt financing to (a) settle existing liabilities, (b) locate a property of merit to explore and develop and (c) support corporate overhead. Although management is of the opinion that sufficient working capital will be obtained to meet the Company's liabilities and commitments as they become due, either through the issuance of promissory notes or an equity financing, there is a risk that additional financing will not be available on a timely basis or on terms acceptable to the Company as market conditions have limited the availability of funds. In the event the Company is unable to arrange necessary financing, the Company may be forced to cease operations.

In the meantime, management have undertaken measures to mitigate ongoing expenditures, including waiving compensation accrued to management and reducing other overhead costs as required. Ongoing costs are currently expected to be funded through the issuance of either promissory notes or securities of the Company.

Promissory Notes

As at July 31, 2023 the Company had outstanding promissory notes totaling \$252,000 (October 31, 2022 - \$221,100). The promissory notes bear interest at 7% per annum, are unsecured and payable on demand.

Interest incurred on the promissory notes for the three and nine months period ended July 31, 2023, totaled \$4,388 and \$12,546, respectively (2022 - \$3,901 and \$11,182, respectively) of which \$8,244 (2022 - \$4,958) has been recorded in accounts payable and accrued liabilities and \$4,302 (2022 - \$6,225) has been recorded in amounts due to related parties.

Overall Performance

The following discussion of the Company's financial performance is based on the unaudited condensed interim financial statements for the three-and nine-month period ended July 31, 2023.

At July 31, 2023, the Company had total assets of \$3,334 (October 31, 2022 - \$1,649), comprising cash of \$2,941 (October 31, 2022 - \$218), prepaid expenses of \$Nil (October 31, 2022 - \$833), and input tax receivables of \$393 (October 31, 2022 - \$598). The increase in cash is a result of \$12,000 of proceeds received in the period from additional promissory notes issued, which was partially offset by ongoing operating activities compromising regulatory compliance and listing fees, transfer agent fees and ancillary office costs. Prepaid expenses represent fees paid to maintain its listing on the NEX Board of the TSX Venture Exchange.

Shareholders' deficit comprises share capital of \$5,968,027 (October 31, 2022 - \$5,968,027), contributed surplus of \$321,029 (October 31, 2022- \$301,051) and a deficit of \$6,699,245 (October 31, 2022 - \$6,649,144). The increase in shareholders' deficit of \$30,123 results from the \$50,101 net loss for the ninemonth period ended July 31, 2023, partially offset by an increase to contributed surplus for share-based payments of \$19,978, representing the fair value recognized from the vesting of stock options to officers and employees of the Company during the period.

The Company has a working capital deficit of \$410,189 at July 31, 2023 compared to a working capital deficit of \$380,066 at October 31, 2022. The increase in working capital deficit is primarily due to the increase in promissory notes payable to fund the ongoing operating expenditures of the Company.

Segmented Information

The Company operates in one business segment, being the acquisition, exploration and development of mineral properties.

Results of Operations

The following discussion and analysis of the Company's financial results of its operations should be read in conjunction with the Company's unaudited condensed interim financial statements for the period ended July 31, 2023:

Nine months ended – July 31, 2023

During the nine-month period ended July 31, 2023, the Company reported a net loss of \$50,101 (2022 - \$27,990). The net loss recognized during the nine-month period ended July 31, 2023 was mainly a result of \$9,961 incurred on transfer agent and regulatory filing fees (2022 - \$9,646), \$6,673 in audit and legal consulting fees (2022 - \$4,616), \$12,546 of interest expense incurred on the Company's outstanding promissory notes (2022 - \$11,182) and \$19,978 in share-based payments from the vesting of stock options from the January 2023 stock option grant (2022 - \$1,405).

Three months ended – July 31, 2023

During the three-month period ended July 31, 2023, the Company reported a net loss of \$11,625 (2022 - \$8,164). The net loss recognized during the three-month period ended July 31, 2023 was mainly a result of \$1,842 incurred on transfer agent and regulatory filing fees (2022 - \$2,129), \$1,750 in audit and legal consulting fees (2022 - \$1,375), \$4,388 of interest expense incurred on the Company's outstanding promissory notes (2022 - \$3,901) and \$3,024 in share-based payments from vesting of stock options from the January 2023 stock option grant (2022 - \$Nil).

Since incorporation, the Company has no operating revenues as it is still in the acquisition and exploration stage.

Note 1 – As the Company has yet to secure a mineral related asset, the Company has no revenue to report during the financial reporting periods noted above.

Net losses in the last eight quarters reflect the presence of minimum operating expenditures, which mainly comprise of listing fees, transfer agent fees, ancillary office costs and audit fees.

The net loss in Q3 2023 continues with the trend of past quarters while mitigating operating expenditures until a property of merit is located. There was a decrease in net loss in Q3 2023 compared to previous quarters mainly as a result of lower share-based payment expense based on options vested during the period.

Critical Accounting Policies

A detailed summary of all the Company's significant accounting policies is included in Note 3 to the audited annual financial statements for the year ended October 31, 2022.

Off Balance Sheet Transactions

There are currently no off-balance sheet arrangements which could have a material effect on current or future results of operations, or the financial condition of the Company.

Outstanding Share Data

As at the date of this report, the Company has 10,217,248 common shares issued and outstanding.

As at the date of this report, there were 800,000 stock options outstanding.

Related Party Transactions

a) Key Management Compensation

Chris Batalha, the former Chief Financial Officer ("CFO"), Corporate Secretary and Director provided notice of resignation from the Company effective December 31, 2022, for personal reasons. Effective January 1, 2023, Erik Marchand was appointed as CFO, Corporate Secretary and Director for the Company.

Key management include the Company's directors, Chief Executive Officer ("CEO"), former CFO and current CFO. During the three and nine months ended July 31, 2023, the Company incurred \$3,024 and \$19,978 respectively, (2022 - \$Nil and \$1,405, respectively) in share-based payments to key management personnel.

b) Promissory notes with related parties

As at July 31, 2023, the Company had \$87,500 (October 31, 2022 - \$77,200) of outstanding promissory notes issued to John Thomas, a director and the CEO of the Company. The promissory notes are unsecured, bear interest at 7% per annum and are payable on demand.

Interest incurred on the promissory notes due to related parties for the three and nine months period ended July 31, 2023, totalled \$1,473 and \$4,302 respectively (2022 - \$2,186 and \$6,225, respectively).

Financial Instruments and Risks

Financial Risk Management

The Board of Directors has overall responsibility for the establishment and oversight of the Company's risk management framework. The Company's financial instruments consist of cash, amounts receivable, accounts payable and accrued liabilities, amounts due to related parties and promissory notes payable.

Cash is designated as held-for-trading and carried at fair value. Amounts receivables are designated as loans and receivables and are measured at amortized cost. Accounts payable and accrued liabilities, amounts due to related parties, and promissory notes payable are classified as other financial liabilities, which are measured at amortized cost.

Fair Value Measurement

A three-level hierarchy exists for fair value measurements based upon the significance of inputs used in making fair value measurements as follows:

- Level 1 quoted prices in active markets for identical assets or liabilities.
- Level 2 inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly (i.e.: as prices) or indirectly (i.e.: derived from prices).
- Level 3 inputs for the asset or liability that are not based on observable market data.

At July 31, 2023, cash was categorized as level 1. The fair values of other financial instruments, which include amounts receivable, accounts payable and accrued liabilities, amounts due to related parties and

promissory notes payable, approximate their carrying values due to the relatively short-term maturity of these instruments.

Financial Instrument Risk Exposure

The Company is exposed in varying degrees to a variety of financial instrument related risks. The Board approves and monitors the risk management processes.

Credit Risk

Credit risk arises from the potential for non-performance by counterparties of contractual financial obligations. The Company's exposure to credit risk is on its cash and amounts receivable.

The Company's cash is being held with large financial institutions. Amounts receivable are comprised of GST receivable from the Government of Canada. The Company's credit risk is mitigated by maintaining its financial liquid assets with highly reputable counterparties. The maximum exposure to credit risk is equal to the fair value or carrying value of the financial assets noted above.

Foreign Exchange Rate Risk

The Company is not exposed to any significant foreign exchange rate risk.

Interest Rate Risk

As the Company's promissory notes bear a fixed interest rate, the Company is not significantly impacted by interest rate risk.

Liquidity Risk

The Company's cash are invested in business accounts which are available on demand. The Company manages liquidity risk by preparing and maintaining cash forecasts, which illustrate cash spent to date and cash needs over the short term. As at July 31, 2023, the Company had total current assets of \$3,334 (October 31, 2022 - \$1,649). The Company's ability to continue operations in the normal course of business is dependent on several factors, including the ability to secure additional financing, all of which are uncertain.

Price Risk

The Company is not currently exposed to price risk with respect to commodity prices. The Company's ability to raise capital to fund exploration and development activities with a potential future project may be subject to risks associated with fluctuations in the market price of commodities.

Commitments

The Company has no commitments of significance.

Legal Proceedings

The Company is not involved in any legal proceedings.

Risks and Uncertainties

The Company is in the business of acquiring, exploring and, if warranted, developing and exploiting natural resource properties. Due to the nature of the Company's proposed business, the following risk factors, among others, will apply:

Going Concern

The financial statements have been prepared on a going concern basis, which assumes that the Company will continue in operation for the foreseeable future and will be able to realize its assets and discharge its liabilities in the normal course of business.

The Company has yet to generate any revenues from operations and as at July 31, 2023, had an accumulated deficit of \$6,669,245 and a working capital deficit of \$410,189, including \$252,000 owing through the issuance of promissory notes, which can be called on demand.

The Company's working capital balance and asset profile currently limits the Company's ability to cover its current liabilities or fund future significant capital expenditures and operations. These conditions, along with other factors indicate the existence of material uncertainties that may cast significant doubt upon the Company's ability to continue as a going concern.

Although management is of the opinion that sufficient working capital will be obtained to meet the Company's liabilities and commitments as they become due, either through the issuance of promissory notes or an equity financing, there is a risk that additional financing will not be available on a timely basis or on terms acceptable to the Company as market conditions have limited the availability of funds. In the event the Company is unable to arrange necessary financing, the Company may be forced to cease operations.

Key Personnel

The Company is dependent upon the services of key executives, including the directors of the Company and a small number of highly skilled and experienced executives and personnel. Due to the relatively small size of the Company, the loss of these persons or the inability of the Company to attract and retain additional highly-skilled employees may adversely affect its business and future operations.

Share Price Volatility and Liquidity

Publicly quoted securities are subject to a relatively high degree of price volatility. It may be anticipated that the quoted market for our shares will be subject to market trends generally, notwithstanding any potential success of us in creating sales and revenues. In addition, our shareholders may be unable to sell significant quantities of shares into the public trading markets without a significant reduction in the price of their shares, if at all.
